2. Authentication of application

The application must be authenticated and sponsored in section 5 by a citizen of Uganda of some standing.

3. Photographs (2)

Two (2) copies of recent photographs of the applicant must be included with the application. These photographs must be taken full face without hat, veil and must not be mounted. The photographs must be printed on normal thin photographic paper and must not be glazed on the reverse side. The recommender is also required to endorse the reverse side of one of the photographs with the words:

“I certify that this is a true likeness of the applicant Mr./Mrs./Miss and add his or her signature.
